**SACRAMENTO REDEVELOPMENT AGENCY OPTS-IN FOR  
PAYMENT PROGRAM TO STAY IN BUSINESS  
California Supreme Court issues partial stay on lawsuit challenging  
State statutes that eliminate redevelopment under 2012 Budget**

**Sacramento, CA** | The Sacramento County Board of Supervisors and the City Council each unanimously approved a recommendation for the Sacramento Redevelopment Agency to “opt in” under AB X1 27 and make payments to the County Auditor-Controller so that it could remain in business.

"We decided to make the payments because redevelopment is critical to Sacramento's economic survival and we were determined to cobble together the funds to try to save it," said La Shelle Dozier, Executive Director of Sacramento Housing and Redevelopment Agency.

Sacramento Redevelopment Agency waits with nearly 425 agencies across the state for the Supreme Court to hear argument in a lawsuit challenging two statutes that force agencies to either dissolve or to opt-in to a continuation program by making annual payments that are intended to help balance the 2011-2012 State budget.

The California Redevelopment Association and the League of California Cities filed the lawsuit claiming that ABX1 26 and ABX1 27 are unconstitutional and violate Proposition 22 passed by voters last November prohibiting the use of redevelopment funds for any other purpose.

On August 11 the Court issued a partial stay that suspends elimination of redevelopment agencies under AB X1 26 with restrictions on certain activity, and leaves AB X1 27 in place allowing agencies to participate in a Voluntary Alternative Redevelopment Plan as part of the State budget. The Court announced that it intends to issue a decision by January 15, 2012 when the first payment is due.

"Until then, we can only move forward with certain projects that were already approved before the Governor signed the budget on June 29," said Dozier. "But even with those approved projects, we can't take any new actions that require changes to contracts, agreements or other activity that would be part of the normal process for a redevelopment project," said Dozier.

Sacramento owes about \$22 million under the payment program for FY 2011-2012 of which \$18.3 million will come from the City redevelopment agency. The County redevelopment agency will contribute approximately \$3.5 million. Subsequent annual payments are estimated at \$4.2 million for the City and \$838,000 for the County. The Agency will suspend its 2011-2012 allocation to its low income housing and moderate income housing funds in order to make the first payment.
