



INVITATION FOR BID

The **Housing Authority of the County of Sacramento** is soliciting sealed bids for Invitation for Bid (IFB) No. 2018018-LGdd for **Twin Rivers Camera Pole 2018**; installation of new 45 foot tall wood pole at south side of the Twin Rivers property for the purpose of mounting a time-lapse camera at 321 Eliza Street, Sacramento, CA 95811. Possible subcontracting trades are Concrete, Low Voltage and Pole Installation. The estimated cost on this project is \$9,000 to \$10,000.

Interested licensed **“A” General Engineering, “B” General or “C-61/D-31” Pole Installation & Maintenance Contractors** should plan to attend the Pre-Bid Conference to be held at 801 12th Street, 2nd Floor, Sacramento, CA 95814 on **May 22, 2108 at 10:00 a.m.** with a site visit following the Pre-Bid Conference. All contractors and potential subcontractors are urged to attend the Pre-Bid Conference including the site inspection. Although attendance is not mandatory, contractors will be required to verify that they are aware of the existing site conditions.

Bids will be received at the Procurement Services Division, 801 12th Street, 2nd Floor, Sacramento, CA 95814 until **10:00 a.m. on Monday, June 4, 2018** at which time and place all bids received will be publicly opened and read aloud.

Per California State Labor Code Section 1771.1 (a), a contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter, unless currently registered and qualified to perform public work pursuant to Section 1725.5. Notwithstanding any other requirements (including federal labor requirements), this contract is subject to compliance monitoring and enforcement by the Department of Industrial Relations (DIR).
