- 2. Substantial Amendment of City of Sacramento and County of Sacramento 2020 One-Year Action Plans including amendments to previous years' Action Plans and the 2020 Coronavirus Aid, Relief, and Economic Security Act funding allocation; and
- 3. Amending the City of Sacramento and County of Sacramento Citizen Participation Plan.

The Consolidated Plan is designed to help local jurisdictions to assess their affordable housing and community development needs, and to make data-driven, place-based investment decisions. The Consolidated Plan is implemented through annual Action Plans, which fund projects and programs addressing priority needs and specific goals. The Action Plan appropriates Community Development Block Grant (CDBG), Housing Opportunities for Persons with AIDS (HOPWA), and Emergency Solutions Grant (ESG) from the U.S. Department of Housing and Urban Development (HUD). Revisions are proposed due to the new federal funds allocated to the City and County to be used to prevent, prepare for, and respond to the coronavirus (COVID-19).

The activities are subject to environmental review under the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA) before the projects are approved for implementation.
