PUBLIC INVITED TO PARTICIPATE IN FOCUS GROUPS ON ANALYSIS TO IMPEDIMENTS TO FAIR HOUSING CHOICE

Sacramento, Calif I The Sacramento Valley Fair Housing Collaborative—the cities of Citrus Heights, Davis, Elk Grove, Folsom, Galt, Isleton, Rancho Cordova, Rocklin, Roseville, Sacramento, and West Sacramento, Sacramento County, SHRA, and the Housing Authorities of Sacramento, Roseville and Yolo—is developing a regional Analysis of Impediments to Fair Housing Choice (AI). The public is invited to attend and provide input in community stakeholder focus groups this month in the process to move Affirmatively Furthering Fair Housing work forward.

The AI is a planning process for collaborative partners to take meaningful actions to overcome historic patterns of segregation, promote fair housing choice and foster inclusive communities that are free from discrimination. An essential element of the AI development is community input to provide local data not available from other sources on residents' experience with housing choice and access to opportunity in the region.

BBC Research & Consulting is conducting the AI on behalf of the Sacramento Valley Fair Housing Collaborative. BBC will facilitate a series of focus groups in six communities to discuss economic and housing barriers to residents in the Sacramento Valley region. This HUD-required study will assess the region's fair housing landscape and develop actionable goals to increase housing choice and access to opportunity for all residents. Although this is a HUD-required study, it involves more than housing. The purpose is to break down barriers that residents face in finding housing and accessing the means for economic opportunity—quality educations, good jobs, public transportation and environmental health.
