



INVITATION FOR BID

The **Sacramento Housing and Redevelopment Agency** as Project Manager for the City of Sacramento and the Housing Authority of the County of Sacramento is soliciting sealed bids for Invitation for Bid (IFB) No. 2019001-LGdd for **Twin Rivers Demolition Phase 2A, 321 Eliza Street**, Sacramento, CA 95811. Scope of work: at 34 buildings at the Twin Rivers complex, perform hazardous abatement on affected units and demolition and remove buildings (including concrete slab foundations) in their entirety. Remove concrete and asphalt parking areas between buildings. Possible subcontracting trades are Asbestos Removal; Building Moving/ Demolition; Construction Clean-up; Construction Zone Traffic Control; General Engineering; and Lead Removal. The estimated bonding range is between \$850,000 and \$950,000.

Interested licensed A-General, B-General and/or C-21 Building/Moving Demolition should plan to attend one of the two Pre-Bid Conferences to be held at **801 12th Street, 2nd Floor, Sacramento, CA:**

- **January 9, 2019 at 10:00 a.m.** with a site visit following the Pre-Bid Conference.
- **January 15, 2019 at 10:00 a.m.** with a site visit following the Pre-Bid Conference.

Please note: contractors possessing a B-General Building Contractor license may only serve as the prime contractor for this project if they subcontract to a C-21 and/or an A-General Engineering Contractor to perform the demolition work.

All contractors and potential subcontractors are urged to attend one of the two Pre-Bid Conferences including the site inspection. Although attendance is not mandatory, contractors will be required to verify that they are aware of the existing site conditions.

Bids will be received at the Procurement Services Division, 801 12th Street, 2nd Floor, Sacramento, California until **2:00 p.m. on January 31, 2019** at which time and place all bids received will be publicly opened and read aloud.

This contract is subject to Federal labor standards, California Labor Code including but not limited to Sections 1771, 1774, 1775, 1776, 1777.5, 1813 and 1815, compliance monitoring and enforcement by SHRA and the California Department of Industrial Relations (DIR), affirmative action requirements, Section 3 Requirements of the HUD Act of 1968, the Davis-Bacon Act, and Minority and Women Owned Business Enterprise standards.

For bids in excess of \$25,000, bidders will be required to furnish and pay for a satisfactory Bid Bond in the amount of not less than 5% of the total bid price. The successful bidder will be required to furnish and pay for a satisfactory Performance Bond and Payment Bond in the amount of not less than 100% of the contract price. Pursuant to the California Public Contract Code Section 22300 the Contractor may request that the Agency substitute a security in the amount of the performance retention.

This is a Public Works project. Per California State Labor Code Section 1771.1 (a), a contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter, unless currently registered and qualified to perform public work pursuant to Section 1725.5. Notwithstanding any other requirements (including federal labor requirements), this contract is subject to compliance monitoring and enforcement by the Department of Industrial Relations (DIR).
