

## ADVERTISEMENT FOR INVITATION FOR BID

The **Housing Authority of the City of Sacramento** is soliciting sealed bids for Invitation for Bid (IFB) No. 1944-DDma for **Redwood and Cypress Waterproofing 2019**, 480 Redwood Avenue, 3725 Cypress Street, Sacramento, CA 95815 and 95838. Prepare surfaces of concrete block exterior walls for new coating, re-point all mortar joints with new tooled joints, and apply new specified coatings over the concrete block. Seal all openings around wall penetrations (light fixtures, handrails, etc.). Replace portion of concrete walk at one of the buildings. Add sheet metal covers over electrical meter panels. Install drywall and rigid insulation at interior side of block walls at selected units. Possible subcontracting trades are Concrete, Drywall, Insulation & Acoustical, Masonry and Painting & Decorating. The estimated bonding range is \$180,000.00 - \$200,000.00.

All contractors and potential subcontractors are urged to attend one of the two Pre-Bid Conferences including the site inspection. Although attendance is not mandatory, contractors will be required to verify that they are aware of the existing site conditions.

Bids will be received at the Procurement Services Division, 801 12<sup>th</sup> Street, 2<sup>nd</sup> Floor, Sacramento, California until **2:00 p.m. on August 12, 2019** at which time and place all bids received will be publicly opened and read aloud.

This contract is subject to Federal labor standards, California Labor Code including but not limited to Sections 1771, 1774, 1775, 1776, 1777.5, 1813 and 1815, compliance monitoring and enforcement by SHRA and the California Department of Industrial Relations (DIR), affirmative action requirements, Section 3 Requirements of the HUD Act of 1968, the Davis-Bacon Act, and Minority and Women Owned Business Enterprise standards.

For bids in excess of \$25,000, bidders will be required to furnish and pay for a satisfactory Bid Bond in the amount of not less than 5% of the total bid price. The successful bidder will be required to furnish and pay for a satisfactory Performance Bond and Payment Bond in the amount of not less than 100% of the contract price. Pursuant to the California Public Contract Code Section 22300 the Contractor may request that the Agency substitute a security in the amount of the performance retention.

This is a Public Works project. Per California State Labor Code Section 1771.1 (a), a contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter, unless currently registered and qualified to perform public work pursuant to Section 1725.5. Notwithstanding any other requirements (including federal labor requirements), this contract is subject to compliance monitoring and enforcement by the Department of Industrial Relations (DIR).
