

**SACRAMENTO HOUSING AND REDEVELOPMENT AGENCY:
NOTICE OF PUBLIC HEARING AND COMMENT PERIOD FOR THE SUBSTANTIAL AMENDMENT #4 TO THE
2020 ANNUAL ACTION PLAN FOR PREVIOUS YEARS' ACTION PLANS, COMMUNITY DEVELOPMENT BLOCK
GRANT (CDBG) AND EMERGENCY SOLUTIONS GRANT (ESG) CORONAVIRUS AID, RELIEF, AND ECONOMIC
SECURITY (CARES) ACT FUNDS**

The Sacramento Housing and Redevelopment Commission will hold a public hearing for the following

1. Substantial Amendment of City of Sacramento 2020 One-Year Action.

The Action Plan appropriates Community Development Block Grant (CDBG), Housing Opportunities for Persons with AIDS (HOPWA), Emergency Solutions Grant (ESG) and CARES Act funds from the U.S. Department of Housing and Urban Development (HUD). Revisions are proposed in order to allocate CDBG and ESG funding from the CARES Act for emergency shelters, facility operation, rehabilitation of a motel that will be used as an emergency shelter and interim housing for the homeless, and other eligible activities.

The activity is subject to environmental review under the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA) before the projects are approved for implementation.
