**SHRA Deputy Executive Director Tyrone Roderick Williams appointed to
Federal Home Loan Bank of San Francisco Affordable Housing Advisory Council**

Sacramento, CA | Tyrone Roderick Williams, Deputy Executive Director of Development for the Sacramento Housing and Redevelopment Agency, has been appointed to serve on the Affordable Housing Advisory Council of the Federal Home Loan Bank of San Francisco. The 15-member panel provides expert guidance on economic development and affordable housing. The AHAC also helps the banks in Arizona, California, and Nevada form community grant and credit programs. **Announced formally by the FHLB**, Williams' appointment is effective through 2021 and fills a vacancy from his predecessor who resigned at the end of 2019.



“I am honored to be selected to serve on the FHLB Affordable Housing Advisory Council. It’s been almost 20 years since a representative from Sacramento was appointed to the council,” said Williams. “This is a very important time and issues of equity, access to capital and financial services in underserved neighborhood is of paramount importance. As an informed and active member on the council, I welcome the opportunity to hear and respond to the concerns, ideas, and banking needs from organizations and residents in the Sacramento region.”

Prior to his appointment as Deputy Executive Director, Williams served as Director of Development from 2014 to 2020. He provides visionary leadership and directs the program innovation, affordable housing, community development, and project financing activities for the Agency which serves the City and County of Sacramento, the City of Sacramento Housing Authority and the Sacramento County Housing Authority.

Williams is responsible for funding services and directing federal entitlement programs. He also directs development finance and new initiatives including programs addressing Opportunity Zones, homelessness and public housing redevelopment activities in both the City of Sacramento and Sacramento County.

Williams oversees fair housing activities and housing policy development and implementation for the Agency. His department provides financing for the development and preservation of long-term multi-family affordable

SHRA (www.shra.org) is a Joint Powers Authority created by the City and County of Sacramento to represent both jurisdictions for affordable housing and community redevelopment needs. SHRA has a FY 2020 budget of \$211.9 million and 246 employees. The Agency owns and/or manages approximately 3,200 units of affordable housing and is one of the largest landlords in Sacramento. housing. Under his leadership, the department has provided over \$350 million in multi-family affordable housing financing, including bonds and loans. He also directs first-time homebuyer programs, compliance monitoring of over 1,200 single-family loans and portfolio management of 1,300 loans totaling \$321 million.

Williams also directs the activities of the Sacramento Promise Zone (sacramentopromisezone.org), coordinating partnerships with over 150 corporate, non-profit, governmental and local organizations to expand services to underserved neighborhoods to date the Promise Zone collaboration partners have been awarded over \$175 million in state and federal funds.
