

## Payment Standards Housing Choice Voucher Program

Households participating in the Housing Choice Voucher (HCV) program receive a subsidy each month to help pay their rent and utilities. The subsidy varies for each household depending upon the household's size and income.

The U. S. Department of Housing and Urban Development (HUD) has mandated the Housing Authority of Sacramento County, to use Fair Market Rents (FMRs) based on zip codes, called Small Area FMRs (SAFMRs), to establish payment standards. The Payment Standard is used to calculate the maximum amount of assistance a household can receive that <u>includes both the contract rent</u> <u>amount and utility allowance</u>.

This is not the maximum rent that can be charged by landlords.

The amount of rent a landlord can charge must be "reasonable" when compared to unassisted rental units in the neighborhood with similar amenities.

The chart below shows the Payment Standard for Sacramento County zip codes by the bedroom sizes listed. When using the chart, choose the payment standard amount that is the lower of the voucher size or the unit size.
